2. APPROVAL OF MINUTES

3. ITEMS FOR INDIVIDUAL CONSIDERATION

- a. Annual Financial and Business Operation Report
- b. Consider and take action on the sale of 0.97 +/- acres of real property, located near the intersection of Rosehill Road and Thackery Road, and authorize the Executive Director to execute such documents necessary to complete the transaction.
- c. Consider and take action on the purchase of 0.04 +/- acres of real property, located near the intersection of E Avenue B and Hopkins Street, and authorize the Executive Director to execute such documents necessary to complete the transaction.

- d. **Consider and take action on the purchase of four parcels of real property, 0.56 +/- acres in aggregate, near the intersection of W State Street and N 3rd Street, and authorize the Executive Director to retain outside legal counsel to pursue the acquisition and further authorize the Executive Director to execute such documents necessary to complete the transaction.**

EXECUTIVE SESSION

- b. **The value, negotiation and potential purchase of real property located at 3316 W. Walnut (551.072); and attorney/client matters concerning privileged and unprivileged client information related to the same (551.071).**
